

# Northfield Township Road District

## RESURFACING BID FORM

### SUBMIT IN DUPLICATE

The undersigned Bidder proposes and agrees, if this Bid is accepted, the **Bid Form and Specifications & Instructions will constitute the Legal Contract** between Northfield Township Road District and the successful Bidder.

The undersigned proposes to furnish all labor, materials, supplies, equipment, and/or services set forth herein, subject to all conditions outlined in the Bid Form and Specifications & Instructions, including the policy and procedures for open and competitive bidding, at prices indicated below.

In submitting this Bid, Bidder represents:

- a. Bidder has examined copies of the Bid Form and Specifications & Instructions.
- b. Bidder has familiarized itself with the nature and extent of the Bid Form and Specifications & Instructions Documents, and all local conditions and legal requirements that in any manner may affect cost, progress, performance, or furnishing of the work, and has made such independent measurements as bidder deems necessary.
- c. This bid is genuine and not made in the interest or on behalf of any undisclosed person, firm or corporation, and is not submitted in conformity with any agreement or rules of any group, association, organization, or corporation; bidder has not directly or indirectly induced or solicited any other bidder to submit a false or sham bid; bidder has not solicited or induced any person, firm, or a corporation to refrain from bidding; and bidder has not sought by collusion to obtain for itself any advantage over any other bidder or over the Northfield Township Road District.
- d. By submission of the bid, bidder certifies, and in the case of a joint bid each part thereto certifies as to his own organization, that in connection with the bid:
  - (1) The prices in the bid have been arrived at independently, without consultation, communication, or agreement, for the purpose of restricting competition, as to any other bidder or with any competitor.
  - (2) Unless otherwise required by law, the prices which have been quoted in the bid have not knowingly been disclosed by the bidder, prior to opening, directly, or indirectly to any other bidder or to any competitor.
  - (3) No attempt has been made or will be made by the bidder to induce any other person or firm to submit or not to submit a bid for the purpose of restricting competition.
- e. **Bidder must meet and be in compliance of the Prevailing Wage Act.**

f. **BID BOND**

All bids shall be accompanied by a bid bond, certified check or cashier's check in the amount of **5%** of the bid.

Northfield Township Road District shall pay the successful bidder every thirty days upon satisfactory delivery of services and lien waivers in accordance with conditions and prices stated in the bidder's bid pursuant to the provisions of the Bid Form and Specifications & Instructions documents. The successful bidder agrees to replace any or all bid items which have been paid for under this contract and which have been rejected for failing to meet the specifications.

The bidder shall submit a request for payment upon completion of work. The request for payment will be processed by the Northfield Township Highway Commissioner in a manner to expedite payment to bidder. If the successful bidder fails or refuses to furnish any part or all of the work quoted, the Northfield Township Highway Commissioner reserves the right to withhold payment until the work is completed.

Bid for paving with **two and one-half (2½") inch bituminous concrete surface course Hot-Mix asphalt surface IL-9.5FG; N50**, in two one and one-quarter (1-1/4") inch lifts, including bituminous material (prime coat) aggregate, sand and sweeping. Include two and one-half (2½") inch bituminous surface removal (include milling and butt joints), complete in place including necessary remedial and preparatory work according to latest State of Illinois specifications for the following streets:

**UNINCORPORATED AREA'S of GLENVIEW & NORTHBROOK**

*Streets will be marked at each end of roads unless they end in a cul-de-sac.*

1. **Westview Dr.** From Landwehr Road to 4301 Westview Drive. Approx., 850 feet long by 22 feet wide.
2. **Overland Pass** - From Westview Dr., to 3208 Overland Pass. Approx. 1,550 feet long by 20 feet wide.
3. **Pleasant Run Dr.** – From Overland Pass to Landwehr Road. Approx. 657 feet long by 22 feet wide.
4. **Evergreen Ln.** – From Sanders Road to Timberlane Drive. Approx. 1,678 feet long by 24 feet wide.
5. **Timberland Ln.** – From 4035 Timberland Drive to 4300 Timberlane Drive. Approx. 1,734 feet long by 20 feet wide.
6. **Deercrest Ln.** - From Techny Rd to 1939 Deercrest Ln including the cul-de-sac. Approx. 1,447 feet long by 24 feet wide.
7. **Western Ave., Located in Northbrook West Subdivision** - From Garden St. to Prairie Ave Approximately 1,880 feet long by 21 feet wide.
8. **Pleasant St., Located in Northbrook West Subdivision** – From Western Ave to Prairie Ave. Approximately 1,263 feet long by 21 feet wide.
